    against requirements of applicable QMS/technical Standards; support client's efforts to
    resolve internal audit findings on-time and within budget
  - Facilitate third-party audit and accreditation activities on behalf of clients. This includes
    coordinating audit scheduling, represent client during third-party audit activities and
    support client's efforts in resolving third-party audit findings.
